Opening remarks by the BSEC PERMIS Executive Manager Ambassador Ashot Kocharian at the 6th International Conference Risk Management in Energy 2023 (online, 13 April 2023)

Mr. Chairman, distinguished participants,

I have the honour to represent the Permanent International Secretariat (PERMIS) of the Black Sea Economic Cooperation Organization (BSEC).

In close cooperation with the BSEC PERMIS the Coordinator of the BSEC- Green Energy Network (GEN) organizes an annual Green Energy Investment Forum, the 9th edition of which will be held this October in Athens with the purpose to boost investments in Green Energy sector in our Member States and target potential investors from all the BSEC Member States in green energy projects.

We are open and interested in further developing a productive teamwork with energy-related international organizations and institutions in promoting the sustainable energy and infrastructure development in the BSEC Region.

Our efforts are focusing on energy security, sustainability, harmonization of the national legislation of the BSEC Member States, the utilization of clean and innovative energy technologies in order to reduce negative environmental effects of non-sustainable fossil fuel technologies.

The region covered by the territories of the BSEC Members States is of paramount geostrategic importance. serving as a very significant Transport and, especially, Energy hub. It extends from the Caspian to the Adriatic seas, it encompasses all countries around Black Sea, the Caucasus and the South Balkans.

Finding innovative approaches to international cooperation and developing coordination mechanisms in the sector of energy becomes more than ever urgent especially in light of current developments and existing challenges.
